

TUITION FEES

(Canadians and Permanent Residents - effective July 1, 2017)

COURSE FEES: Students are assessed course fees at the rate that is in effect at the course start date. Course fees are \$795/3-credit course, \$1590/6-credit course, and \$2,385/9-credit course. Students may audit courses, if pre-requisites are met; instructor permission must be obtained to audit an online course. Tuition for auditing online courses is the same as credit course tuition; all other courses may be audited for half the credit course fee. Registration deadlines apply to courses; a late fee of \$75 is applied where late registrations are accepted. Fees may change without notice. Some degree program requirements may be fulfilled at other institutions with the permission of the Department Chair; students are responsible for any course and administrative fees in effect at that institution.

PROGRAM FEES: Degree and Certificate program fees are detailed below. Students may avoid annual tuition increases by paying the entire program fee in advance. Program fees are paid during the first four years of the program, and cover collegiums and general academic and administrative support. Semi-annual installments are due July 31 and January 31. The entire program fee is payable regardless of the number of years students take to complete the program. The continuation fee applies only to those students taking longer than four years to complete their program. Students do not pay a Continuation Fee in the year they graduate; if a student pays the Continuation Fee and subsequently completes all academic work (including submission of all thesis documents), they will receive a prorated refund of the continuation fee. There is a non-refundable application fee for all degree programs: Canadian and Permanent Resident applicants \$195, International applicants \$390.
