

# TUITION FEES

(International Students – effective July 1, 2018)

**COURSE FEES:** Students are assessed course fees at the rate that is in effect at the course start date. Course fees are \$810/3-credit course, \$1,620/6-credit course, and \$2,430/9-credit course. Students may audit courses, if pre-requisites are met; instructor permission must be obtained to audit an online course. Tuition for auditing online courses is the same as credit course tuition; other courses may be audited for half the credit course fee. Registration deadlines apply to courses; a late fee of \$75 is applied where late registrations are accepted. Fees may change without notice. Some program requirements may be fulfilled at other institutions with permission of the Department Chair or Associate Chair; students are responsible for any fees in effect at that institution.

**PROGRAM FEES:** Degree and Certificate Program Fees are detailed below. Students may avoid annual tuition increases by paying the entire Program Fee in advance. Degree and Post-Master's Program Fees are paid in semi-annual or annual installments over the first four years of the program; Graduate Certificate Program Fees are paid in annual installments over the first two years of the program. Program Fees cover general academic and administrative support. The **entire Program Fee is payable regardless of the number of years students take to complete the program.** The continuation fee applies only to those students taking longer than four years to complete their program. Students do not pay a continuation fee in the academic year they graduate; the academic year at SSC is July 1 to June 30, and graduation is in November. There is a non-refundable application fee for all degree programs: Canadian and Permanent Resident applicants \$195, International applicants \$390.
